Re: Yukon Energy Corporation (YEC) 2008-2009 General Rate Application (GRA)

Further to Board Order 2008-15 we wish to advise that the City of Whitehorse intends to participate and wishes to be registered as an Intervener in the YEC GRA presently filed before the Yukon Utilities Board (the "Board").

While the City of Whitehorse understands that the approval of the YEC GRA would generally lead to reduced rates, it considers that it would still be prudent to conduct its due diligence in evaluating any forecasted increases in specific costs or rates to ensure that they are reasonable and warranted. The revenue forecasts contained in the YEC GRA should also be examined for reasonableness.

The City of Whitehorse represents the interests of its residents which include all classes of customer of YEC taking service within the City and it intends to take the steps necessary to analyze the impact on the interests of those customers and to advocate appropriately on their behalf. The City is itself a customer of YEC and thus is interested in ensuring that forecasts of both costs and revenues are reasonable. The City of Whitehorse considers that both it and its residents have an interest in ensuring that rates that are approved are the lowest possible consistent with good quality and reliable service.

The City of Whitehorse intends to participate in the YEC workshop and the pre-hearing conference to be held on January 6 and 7, 2009 respectively, and to participate in the other proceeding steps as necessary to protect the interests of itself and its residents. Should the City's

review of the application and information provided in early January or in response to information requests lead the City to the conclusion that there are no issues with the YEC GRA as filed, it intends to so inform the Board and withdraw from further participation. On the other hand if issues are identified, it will intend to proceed through the various processes in an attempt to ensure that its interests and those of its residents are protected with respect to those issues.
