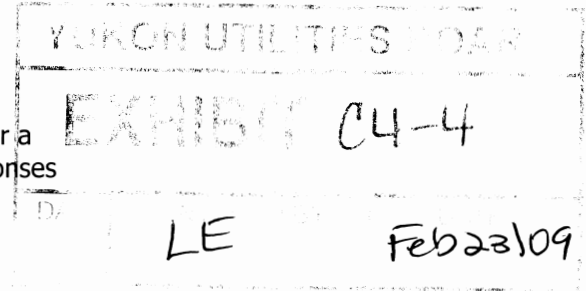
Yukon Utilities Board:
