**Re: YEC 2008-2009 General Rate Application  
2008 Updates - Responses to Information Requests**

Dear Ms. Lemke:

The Utilities Consumers' Group is in receipt of the responses to information requests submitted by Yukon Energy Corporation on February 27 and March 6, 2009.

In reviewing YEC's responses to UCG's requests, YEC has deferred answers to several of UCG's questions, intending to provide an update filing sometime between now and the oral hearing that, apparently, will include answers to deferred questions.

Based on the schedule provided in the Notice of Application, UCG is not aware of the timing for the update nor of any process to test updated information through information requests prior to the scheduled May 2009 hearing. The only provision for additional evidence is related to YEC rebuttal evidence to any intervenor evidence submitted.

The UCG respectfully requests that the Yukon Utilities Board direct YEC to provide an indication on when it will be providing its 2008 update and when more complete responses will be submitted to the following information requests, deferred by YEC to the update:

**1. UCG-YEC-1-14**

YEC failed to respond to part (b) of this information request.

YEC failed to provide amounts recovered through Rider J for 2008 stating that the actuals for 2008 were not currently available and would be supplied "with the update filing".

The UCG requests that YEC be directed to provide the requested information related to Rider J.

**2. UCG-YEC-1-23**

YEC failed to respond to fully to this information request.

YEC refers to an attachment to CW-YEC-1-32 that, to UCG's knowledge, was not provided. YEC also refers to 2008 data that would be supplied "with the update filing".

The UCG requests that YEC be directed to provide the requested information.

**3. UCG-YEC-1-37**

YEC failed to respond to fully to part (a) to this information request.

YEC was asked to provide an update to Table 3.3 for 2008 actual. YEC indicated that 2008 data would be supplied "with the update filing".
