This is my fifth appearance in the last four years as an intervener in front of the board. While some of my conclusions were perhaps controversial, I was thorough and exacting in my research and in the end, my contributions provided value in highlighting N-1 capacity and permitting issues, with some of my arguments, such as the applicability of Section 49 of YESAA eventually being accepted to be correct. Regardless of the final results, I believe my ideas, approach and attention to detail added value to the process. In a public hearing, input and analysis from members of the public is important to the validity of the process, even if that input is at times challenging. I attended all days of the hearing. My time claim continues to be based on an hourly rate of \$45. I understand that the hourly rate is at the discretion of the Board.

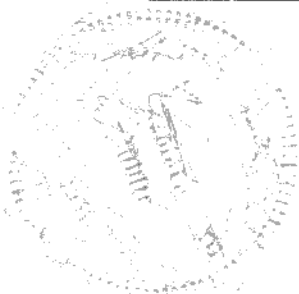
