Re: Nathaniel Yee Participant Cost Award claim for the Yukon Energy Corporation 2021 General Rate Application proceeding before the Yukon Utilities Board

This letter and the attached supporting information constitute my Participant Cost Award claim for the Yukon Energy Corporation 2021 GRA.

I have reviewed the Rules of Practice and Scale of Costs documents, and included the required forms and a more detailed time record in support of my claim.

While I do not have previous experience in the world of public utility regulation, I have previously held positions of Senior Systems Analyst at General Motors, Electronic Data Systems and Gale, then a division of Thomson Publishing. Given that this was my first experience as an intervenor, my time claim is based on an hourly rate of \$35. I understand that the hourly rate is at the discretion of the Board.

While I did not succeed in convincing the board to exclude diesel rental costs from the rate base, I did show inconsistencies in the GRA, and inconsistencies between what YEC was presenting to the Board and what was presented to YESAB and Environment Yukon. I believe my approach was complimentary to that of the City of Whitehorse in also recommending the exclusion of diesel rental costs for entirely different reasons.

It was a learning experience, and I look forward to continuing to be involved as time permits.
